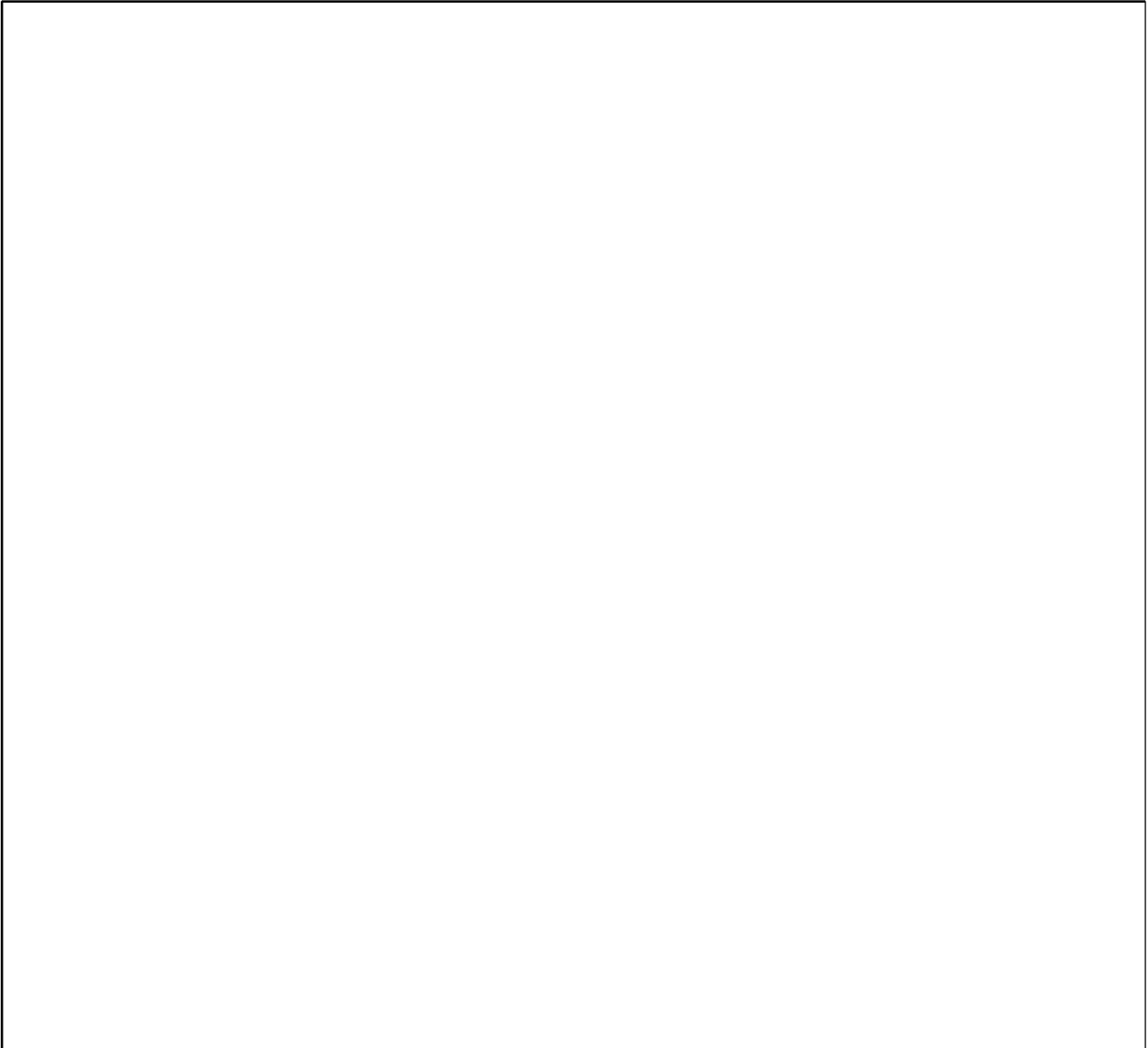

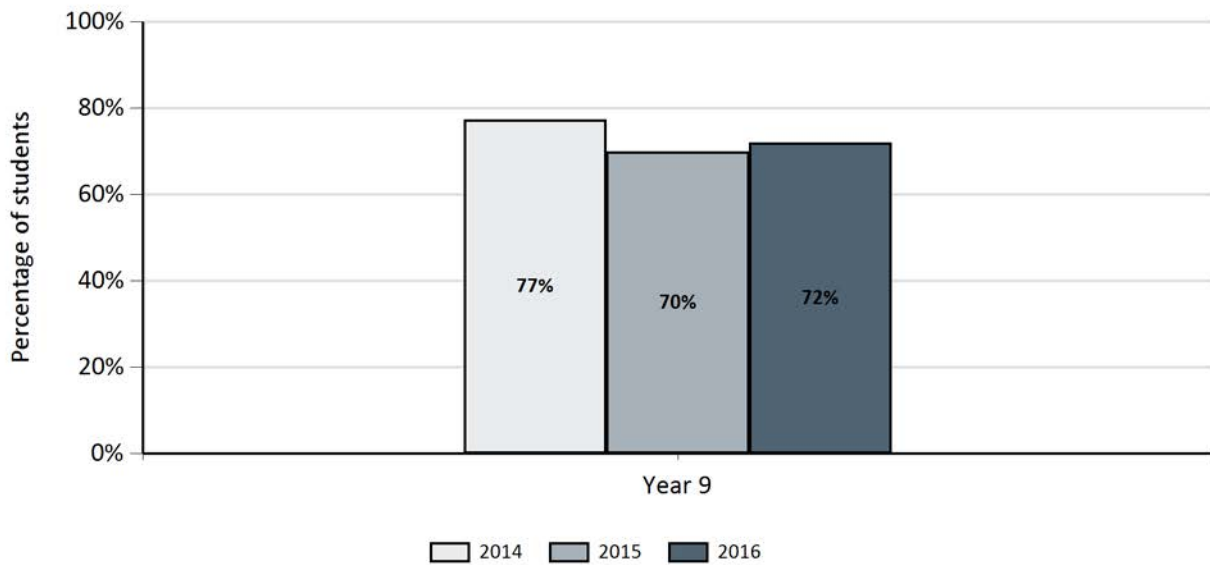

### NAPLAN Proficiency

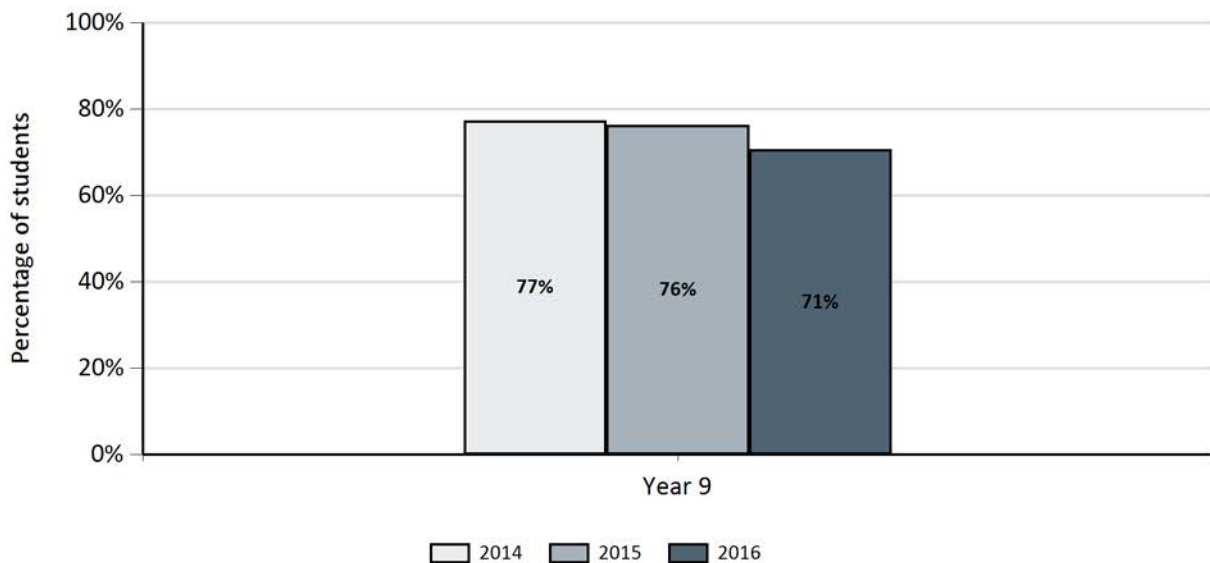
